The undersigned vendor agrees to exercise the utmost care in the use of facilities and properties of the Roanoke Farmers Market and town of Roanoke. The vendor also agrees to indemnify and to hold

harmless the Town of Roanoke, Roanoke Businessman’s Assoc. and the Roanoke Farmer’s Market and its officers, employees agents from any and all claims actions judgements losses costs, (including reasonable attorney fees) and damages whatsoever; including claims arising by reason of accident injury or death caused to persons or property of any kind, arising out of, in connection with or incidental to the Roanoke Farmers Market, except caused by the sole negligence of the Roanoke Farmers Market and the Town of Roanoke. Should a vendor at any time occupy the premises in a manner contrary to the rules of the market, or in any manner which is hazardous or offensive to the public or other vendors, upon request of market master, vendor shall immediately cease such offending conduct. Failure to immediately conform its conduct as requested shall be cause to revoke this agreement and the vendor membership. Upon revocation, the vendor shall promptly vacate the premises. Upon failure to so vacate, the Market is authorized to remove all property of vendor from the premises at the vendor’s expense. Roanoke Farmers’ Market is relieved and discharged from any and all losses or damage occasioned from such removal. The Market shall not be responsible for storage or safekeeping of property so removed.

The Market is open from 9:00 am to 1:00 pm, with set up from 7:00 am to 8:45 am. Your reserved space is expected to be completely set up and all vehicles off the street by 8:45 and no later. Tear down will not begin until after the market closes at 1:00.

Tables and carts are available on a first come first serve basis, free of charge. No chairs will be provided.
